**► HOW TO CONTACT LEGISLATORS ◀**

To be true representatives of the people, legislators need to know the thinking of their constituents. Your opinions help determine how your elected officials vote on a given issue, or what kind of policy decisions they may make.

**For best results:**

- The most effective way to reach your elected official is in person—go to their office or a town hall meeting or coffee hour they are hosting.
- Phone calls are the next most effective, then use email.
- Use your own words; don't use attack words. Be brief and state reasons for your opinion.
- Identify the issue or the bill by its number. Write or call when a bill is being formulated or while it is still in committee – that is, before it gets to the floor to be voted on.
- Be constructive, and ask for a response.
- Give your name and your return address.
